

# Charleston's Board of Zoning Appeals-Site Design tackles DI agenda items

Recent meeting addresses requests about trees and parking

Charleston is a city defined by two things: its charm and its location as the heart of the South Carolina Lowcountry. The beautiful, moss-strewn Live Oak trees, the seemingly endless marshes and creeks, the peninsula itself, surrounded by the embrace of a naturally-deep harbor and flanked by a network of wide, navigable rivers, the environment made Charleston what it is today.

As such, the topic of how the City manages its greatest resource has permeated nearly every aspect of local politics since the inception of Charlestowne in 1670. Today, our municipal government's relationship with the natural world is managed by a series of citizen-led boards that operate under the umbrella of Charleston's Department of Planning, Preservation & Sustainability.

#### WHAT IS THE BZA?

When it comes to project proposals, City Council gets the final say. Projects must proceed successfully through the Planning Commission, a body made up of representatives nominated by members of City Council and whose decisions are reviewed and voted on ultimately by City Council itself. Before a

project matriculates up to those bodies, however, arguably where the rubber meets the road in municipal planning, much of the action takes place at the lower levels of city government, most notably at the City's Board of Zoning Ap-

There are two arms of the BZA, one for zoning and one for site design. Given the Daniel Island Master Plan guides zoning policy on the

island, the BZA-Zoning, for Daniel Islanders, is a municipal body that carries little weight. When it comes to the site design arm of the BZA however, Daniel Island residents are rapidly familiarizing themselves with the body, its members and the sway it holds.

And what they have learned is that the decisions the board makes, on issues like the layout of a new development, the allowance of

an individual or company to remove a "grand" tree, or the facade of a new structure slated for Daniel Island Town Center, affect everyone in the tightly-knit town of Daniel Island.

Awareness of the importance of the BZA-SD to the quality of life on Daniel Island has grown with the island itself. Daniel Island growth has come in waves, particularly one big wave that began with the rebound of the financial markets a few years ago. That trend has driven Daniel Island developers, leaders, and citizens alike to attend BZA meetings of relevance in greater numbers, as was the case last Wednesday, when the body addressed a trio of agenda items relevant to the community.

#### THE TREE DEBATE

One of the Daniel Island projects discussed at the meeting was a proposal to create a sizable subdivision slated for what is now a highlywooded area across Fairbanks Drive from Governors Park. A request by the developer for a variance from the City's law on "grand trees" to remove four Live Oaks (with trunk diameters of 30 inches) and another special exception to remove a two-foot Water Oak, was approved after the group discussed the health of the trees.

According to a report from ISA Certified Arborist Van Adkins, who performed a survey of the land, four of the five trees in question

# A homage to hometown happenings

No matter where my travels take me, I always seek out the local newspaper.

I know. My smartphone easily provides more detail about a town

than I will ever need.

But the local paper does so much more. That's because it fits the many pieces of the community puzzle together. Where else can you get a glimpse of what a citizenry most values and fears - all within a few recyclable pages?

In the tiny town where I grew up, the local paper was a powerful tool - no doubt for many reasons beyond my young comprehension. However, I looked forward to the daily delivery for two simple reasons.

First, I loved to read the personal stories - from tragedy to triumph -about the people in my own community. It was the first inkling I had that I might be part of something larger than the family who lived at 12 Parkview.

Second, I couldn't wait to hear the interesting dinner conversations that some tidbit in the paper was bound to spark. Of course, my favorites were the most heated discussions. And when my parents resorted to spelling out words? Well, let's just say the training led to considerable success in my grade school spelling bees!

Decades of educational publishing experience later, I know my hometown paper was just one arrow in the successful child-raising quiver my parents used. But it was an important tool, and the outcomes it helped produce are still of the utmost importance today.

You see, building a strong sense of place plays a key part in a child's social and emotional development. When children connect with the community around them, it helps them develop their own personal identity. An added benefit is the sense of

stewardship it often inspires.

And the value of generating meaningful conversations? In my view, it's off the charts. Too often in our busy world, dialogue with our kids tends toward the practical (Did you pick up your toys?) rather than the profound (Keep trying even when it's hard!). So any tool that inspires discussion of such issues as friendship and community should be deeply valued. Why? Because that's when our own stories of personal grit and resilience begin to flow.

And aren't those the kind of hometown happenings that we really want our children to remember?

# Three things your face reveals about you

What does your face reveal about you? Far more than you might imagine.

A series of fascinating studies, conducted by face-readers from around the world, have drawn strong links between facial structure and a full range of human characteristics – including intelligence, extraversion, conscientiousness, cooperation, dominance, courage, cowardice, impudence, aggression and sexual orientation. We'll touch on three today.

**EXTRAVERSION** (those who enjoy socializing more than being alone)

Said psychologist Vinita Mehta, in a piece for Psychology Today: "For women, extraversion was the only significant factor that correlated with facial structure. Higher levels of extraversion were related to more protruding nose and lips, a recessive chin and masseter muscles (the jaw muscles used in chewing). By contrast, the face of those with lower extraversion levels showed the reverse pattern, in which the area around the nose appeared to press against the face. These findings suggest that perhaps psychological traits can – to some degree – be read on a person's face, though more studies would be needed to understand this phenomenon."

#### LIFESTYLE

A BBC report discussed the link between skin color and lifestyle. Said the report: "... very subtle differences in skin color can also reveal your health secrets." They reported on research conducted by Benedict Jones, University of Glasgow, and Carmen Lefevre, Northumbria University, noting: "Jones and Lefevre emphasize this has nothing to do with the tones associated with ethnicity, but barely-no-

ticeable tints that may reflect differences in lifestyle. You appear to be in more robust health, for instance, if your skin has a slightly yellowish, golden tone." According to Lefevre, the report said, when you've eaten enough carotenoids (in orange and red fruit and vegetables) "they layer in the skin and dye it yellow." The glow of health, said the BBC report, "in turn, contributes significantly to your physical attraction – more so, in fact, than the more overt tones that might accompany a trip to the tanning salon." The report adds: "A blush of pink, meanwhile, should signal the good circulation that comes with an active lifestyle - and it might also be a sign of a woman's fertility."

#### **AGGRESSION**

According to psychologist Mehta, "studies have found that the ratio of facial width-to-height (i.e., how narrow or wide the face is) is associated with aggression." She highlights two studies in which participants viewed photos of men whose "behavioral aggressiveness had been assessed." In one study,

photos were glanced for 1200 milliseconds; in another, just 39 milliseconds. Said Mehta:

"These findings support the notion that facial width-to-height ratio may be an advertisement of aggressiveness, and is consistent with research demonstrating that higher levels of testosterone are related to both wider faces and dominant behavior in men."

Three related points of interest:

1. Jobseekers beware! From a businessinsider.com report: Australia "people reader" Alan Stevens "is developing a system that will match career paths to a collection of personality traits that he says can be determined from jobseekers' facial dimensions."


- **2. Fleeting emotions.** From a New York Times article: "Dr. [Paul] Ekman's research tool: FACS, or Facial Action Coding System, [deciphers] which of the 43 muscles in the face are working at any given moment, even when an emotion is so fleeting that the person experiencing it may not be conscious of it."

# Are you at risk for osteoporosis?

#### City board considers trees and parking on DI

could and should be removed. After settling the matter of the fifth tree, which the applicant, engineering firm Freeman Milligan successfully argued should be removed, the board voted to approve the request. Just like that, the meeting was off with a buzz.

And while the Fairbanks Drive project was important, Daniel Island's collective eye, by evidence of a spree of activity seen on various island Facebook pages, was an agenda item request submitted by Daniel Island resident Lisa Pieretti. The BZA-SD was asked by Pieretti to reconsider their April 5 decision to grant a variance to remove 12 trees on Rhoden Island, a 17-acre tract slated for a subdivision of around 100 homes. Pieretti has collected over 400 signatures in support of keeping the trees since addressing the board on the issue at the April 5 BZA meeting.

"As it says up there on the wall 'Please turn off your cell phones," began the City's head planner Eric Schultz, pointing to a posted sign in the room. "But I'm going to break that rule, because I'm expecting some late-breaking news from an applicant who is possibly in route... and possibly not."

That applicant was Pieretti, who ultimately did not attend the meeting but informed Schultz via email eight minutes after the session commenced that she was dropping her appeal.

"Her email reads, 'I have repealed my appeal,'" said Shultz, staring at his phone quixotically. "Ok, so that's official, the appeal has been withdrawn."

#### PARKING CONUNDRUM

Four variance applications from across the City and two full hours later, Daniel Island was again, front and center. Island developer Mike White was slated to discuss his request to reconfigure the parking lot at the building he owns at 259 Seven Farms Drive, so as to add four additional parking spaces. The request was deferred from the board's April meeting to last week's session. By the time the board took up the matter, what had been a crowd of more than 40 had dwindled down to three, two of whom being White and Jane Baker, who was in attendance to officially represent the Daniel Island

Town Association on the matter.

In White's proposal, he asked to change what is now an "H" parking lot pattern into an "I" pattern.

"This was a building on Daniel Island headed for blight," said White. "The property owner was an absentee landlord and the lot is in disrepair."

"I do want to pursue that with the Daniel Island Company, but today the people need parking on Daniel Island," he continued. "This to me is a common sense, pro-business solution to an ordinance that's perhaps misapplied on this smaller property."


Before proceeding, Schultz asked a board member to read for the record a letter from Mary Stuart Sutton of the Daniel Island Architecture Review Board (ARB) stating that her group favored deferring the request to allow White's team to pursue some alternative solutions to the issue. And while Sutton wasn't at the meeting, when asked whether there was anyone in the room who wanted to speak against the request, Baker addressed the board.

On behalf of the Daniel Island Town Association (DITA), Baker reported that she and Matt Sloan, in his capacity as chair of the DITA board, recently met with White to offer him, at no charge, a piece of "common area" property in between the parking lot and an adjacent retention pond. The green space could potentially be used for additional parking, added Baker. They asked White to defer so the project could be further vetted, she continued, but he declined.

At last week's meeting, Baker expressed her concerns about the parking reconfiguration, telling the board that Daniel Island zoning does not allow for what White is requesting.

"We support the Daniel Island ARB's recommendation that the request be again deferred," said Baker, before resting her case. "If this is done, the precedent it will set, this will be the beginning of the dominos starting to fall on Daniel Island's master plan zoning."

After the exhaustive, three-hour meeting and a lengthy discussion, the board voted to again send White and the project back through the process with yet another deferral. White will be presenting an updated proposal to the body at their next meeting on Wednesday, June 7 at 5 p.m.

# **'Spies in the family'**

# DI resident pens real life espionage thriller

It is a story that could easily play out in an episode of "Homeland" on Netflix, "The Americans" on F/X or in any number of intrigue-filled spy dramas on the big screen these days. A Russian spy turns to provide secrets to the United States, while working with a CIA agent based in India. Together, they avert a potential nuclear meltdown between the two superpowers. Sound far-fetched? Not to Daniel Island resident Eva Dillon. For her, in the most personal way, every word of it is true.

The CIA agent was her father, Paul Dillon, and the Russian spy was World War II hero Dmitri Fedorovich Polyakov. And Eva has written a book documenting the pair's pivotal relationship during the Cold War. Already attracting rave reviews, the narrative is entitled "SPIES IN THE FAMILY: An American Spymaster, His Russian Crown Jewel, and the Friendship That Helped End the Cold War." Eva recently shared details about her family's story, and the process she undertook in writing the book, as the keynote speaker at the April 12 Daniel Island Speakers Series event.

In the summer of 1975, when Eva was just 17 years old, a newspaper article exposed Paul Dillon as a CIA officer. In what Eva would call a "WikiLeaks scandal of the 1970s," his position was also "outed" in a tell-all book by Philip Agee. Her father died at age 53 in 1980, but she would only come to learn the full extent of his work after her mother's death in 1997.

Eva told the capacity crowd gathered in the main ballroom at the Daniel Island Club that a box discovered in her mother's attic inspired her to explore her father's past.

"...The box contained a collection of documents and papers," said Eva, who grew up believing her father worked for the U.S. State Department in a position that necessitated frequent moves around the globe. "We took it downstairs, and later, while my siblings and I were sitting around the dining room table talking about arrangements for selling the house, my husband, JL, pulled a magazine out of the box and started reading."

JL mentioned that Eva's father's name was listed in an article and that he had handled a Soviet General during the Cold War whose code name was "TOPHAT." The piece went on to report that TOPHAT was sent as a military at-

tache to India, where Paul Dillon, an ex-marine from Boston, was dispatched to serve as his CIA case officer.

"My mother, probably keeping a vow to my father not to reveal anything during their

lifetimes, hadn't wanted to tell us herself, but clearly wanted us to know by leaving behind the article and other documents," said Eva. "And that, in those pre-internet days before news found you rather than you finding it in a dusty box in an attic, is when I discovered the magnitude of my father's secret career."

The discovery prompted Eva to learn more about her father's CIA days - and about Polyakov. She wondered why he was so important, about the nature of his relationship with her father, and about the political impact of their collaboration.

"I wondered, also, what kind of life the general had led in Russia, on the other side of the Iron Curtain," said Eva to her audience. "Did he have children? What was it like for them to grow up in the Soviet Union with a spy for a father, compared to us?"

The magazine article had also mentioned a betrayal - and Eva was determined to find out more. Over the course of three years, she interviewed more than 18 of Paul Dillon's former CIA colleagues and other intelligence professionals, some of whom asked not to be identified. She poured through works written by investigative journalists and spy book writers, as well as CIA and FBI reports, and various media from Russia and the former Soviet Union. But Eva considers Polyakov's son, Alexander, to be her most "cherished source."

"What came out of all of this research is an intimate double family memoir, within a

broader Cold War history, spanning 50 years and three continents," explained Eva, while citing the similarities of concerns over Vladimir Putin's intentions and aggressions today. "... What I strove to do with my book was to show how geo-political events between governments affect real people in profound ways. One person in particular, the book's main protagonist and my primary motivation for writing it, and hence, the book's dedication, to honor Dmitri Fedorovich Polyakov."

Eva would go on to learn much more about Polyakov and the unique asset he was to the United States during a critical time in our history. He was not tempted by the luxuries of the West, she explained to her Daniel Island audience, a weakness that often compromised other Soviet assets. Although his actions clearly put his life at risk, Polyakov didn't ask for money or political asylum.

"Rather, he was motivated by a desire to lessen the very real threat of nuclear war by helping the Americans better interpret the Soviet leadership's thinking and intentions," continued Eva. "He considered himself a Russian patriot, seeing the Soviet leaders as corrupt thugs, mocking the sacrifices that the Russian people had made during the war. At the height of the Cold War, Polyakov offered the CIA an unfiltered view into the vault of Soviet intelligence."

But perhaps the most significant information Polyakov was able to convey to his American counterparts, said Eva, was that the Soviet government did not believe it could prevail in a nuclear confrontation with the U.S. That realization, she continued, served to degrade the Kremlin's ability to threaten America and her allies, and diffuse tensions - "eventually leading to disarmament talks between the superpowers."

Throughout much of Polyakov's covert involvement with the U.S, he worked alongside Paul Dillon, with whom he would develop a close friendship based on mutual respect.

"It was in Burma where Polyakov and my father first met," explained Eva. "But it was in India where they became close, after we moved there in 1973. Polyakov had a reputation inside the CIA of being unknowable and humorless. But all of that changed with my father."


Eva described her father as "warm and sentient" - and someone who "imparted a preternatural sense of trustworthiness - traits even the KGB would later acknowledge." She did not divulge to her audience what would become of Polyakov after he returned to Russia, and instead encouraged all in attendance to read the book

For Eva, who spent 25 years in the magazine publishing business for the likes of Vogue, Harper's Bazaar, Glamour and The New Yorker, writing "SPIES IN THE FAMILY" has

been a labor of love. Recently, Kirkus Reviews awarded the book a coveted "Kirkus Star," given to only 10 percent of the review site's books. Eva, a former president of Reader's Digest who holds a bachelor's degree in music from Virginia Commonwealth University, hopes the real life espionage thriller will illuminate a once secret relationship that quite literally changed the world.

"I didn't want to write the book that a journalist or historian would, and should, write some day," explained Eva. "I wanted to write the book by a daughter, infusing the personal, human interest aspect into an incredible Cold War story, as it revealed itself to me, and to Alexander Polyakov. So, I seized the opportunity to tell my father's and Polyakov's story as a journalist could not, from the perspective of a daughter, and a son, in all of its newsworthy, and human, ways."

# The countdown is on for Philip Simmons High School completion

Updates provided at school's first PTSA meeting

Eighty days, 16 hours, 27 minutes, and nine seconds. As of the evening of May 4, when Philip Simmons High School's new Parent Teacher Student Association held its first official meeting, that was the amount of time left until "move in day" at the long-awaited facility. Principal Dr. James Spencer has the countdown on an app on his phone and eagerly checks it every day.

"We expect to take occupancy of the building on July 28," he said. "... That's how much time we have left, so we're pretty excited about that...We are on schedule and under budget, and when you're doing construction, that's the bottom line."

Spencer, along with Assistant Principal and Athletic Director Brion Packett and new PSHS head football coach Eric Bendig, updated parents and other community members in attendance at the meeting about the school's

portant thing is we are already establishing a culture of positivity, of high expectations and of academic excellence," noted Spencer.

"We're getting closer and the detail that is put into every aspect of the school, from the

"The best of the best work at Philip Simmons High School," said Packett, who noted that they have received well over 100 applications for positions thus far. "Every person


we've spoken to, and spoken with, is a cut above the rest. And that means something. They're gonna be able to get it done in the classroom. They're gonna help us with our vision and core values."


brings to it."

# **Is your leadership adrift?**

Set your course by the stars, not by the lights of every passing ship. - Omar N. Bradlev

One of the dangers I have observed over my years in leadership is the leader who tends to stray off course. It's an easy trap to fall victim to and I have been there myself a few times.

It tends to happen when we are not focused on our "one thing" and are chasing rabbits down trails where we have no business going. And because we are distracted and we didn't say "no" when we should have, we drift off course. It's usually never intentional, but we are adrift nonetheless and we need to correct our course.

Writing in his book "Simplify," author Bill Hybels poses an intriguing set of questions that started me thinking about this. He writes:

"Are you in the right race? Or have you accidentally drifted into a race that is mostly in vain? Are your best efforts going toward a race that results in fleeting applause? Or do you strive for material gain, which rusts, rots, and depreciates? Or for passing pleasures that don't amount to a hill of beans in the eternal scheme of things?"

Those are some powerful and thought provoking questions. Staying on course requires intentionality on your part as a leader. What does being adrift look like as a leader? How do you know? Let's explore five possibilities.

#### YOUR LEADERSHIP IS ADRIFT WHEN YOU TRY TO RUN SOME-**ONE ELSE'S RACE**

When the race ceases to be your own you are adrift. This happens when you are not being true to yourself. Each of us has our own race and our own lane in which to run it. Quit trying to be the person in the lane next to you and be the person God created you to be. When you do this you will stop drifting.

#### YOUR LEADERSHIP IS ADRIFT WHEN YOU MISTAKE ALL THAT **GLITTERS FOR YOUR TRUE** NORTH

As the statement above mentions, you must not set your course by the lights of the passing ships, but by the stars. Leaders who are adrift are frustrated because they didn't keep their sights set on the star that is guiding them in their race. Forget about the other glimmering lights and get your focus back to where it belongs.

#### YOUR LEADERSHIP IS ADRIFT WHEN YOU FAIL TO SET PROPER **BOUNDARIES**

Leaders drift when they think they can be all things to all people and fail to set realistic, proper, and necessary boundaries. Without boundaries, there is no buffer in place to steer you back on course. You have to establish boundaries and stick by them. Otherwise, you will be drawn off course by every glittering light that comes

#### YOUR LEADERSHIP IS ADRIFT WHEN YOU CHASE APPLAUSE AND APPROVAL

This is one of the easiest traps to fall for as a leader. After all, who doesn't enjoy the applause and approval that stokes our ego? But if this is your motivation for being a leader, you are setting yourself up for disappointment and you will always be adrift. When your focus is on developing your character and integrity you will never have to worry about approval.

#### YOUR LEADERSHIP IS ADRIFT WHEN THERE IS NO ACCOUNT-**ABILITY**

Accountability is crucial to your success as a leader. It's also what will keep you from drifting. When you have someone that has permission to speak truth into your life, that person can be an invaluable benefit to you as a leader. Do you have such a person? If not, let me encourage you to find one. The writer in Proverbs 22:15 said, "Refuse good advice and watch your plans fail; take good counsel and watch them succeed." (The Message).

As a leader, there is nothing more frustrating than being adrift. The good news? You don't have to be when you know the warning signs. Stop drifting and get your focus back on what matters most.

# BE and HHS sprint to track and field state meet

Hanahan coach David Morbitzer is hoping to ride the wave of momentum – and talent – as the Hawks prepare for the Class AAA State Track and Field Championships this weekend in Columbia.

The Hawk boys won the Lower State championship Saturday over Bishop England, scoring 119 points. Bishop England was second with 93 and Waccamaw third with 67.

The Hawks used a speedy veteran, a crafty rookie and some impressive relay runners to capture the title.

The speedy veteran is Quincy Mitchell, who shone brightly Saturday with 28 points in the individual sprints. The crafty rookie is Noah Ward, an eighth-grader who was good enough to win the 1,600- and 3,200-meter runs.

"We did really well," Morbitzer said. "Quincy had a great day and Noah was outstanding. The relay teams got the job done as well."

Hanahan finished second at last year's state meet, but Morbitzer feels this could be the year the Hawks swoop down and grab the biggest trophy that the High School League awards at the end of the day.

"We hope we can win the whole thing," Morbitzer said. "If everything goes well and we run like we're capable of, we can do it."

Mitchell will conclude his track career Saturday. He hit full stride Saturday and hopes to end it with an exclamation point this weekend.

He won the 100-meter dash with a national elite time of 10.46 and just missed breaking Sam Denmark's school record in the 200-meter dash with a time of 21.45, just .03 seconds off the mark. Mitchell claimed second in the 400-meter dash in 50.42.

"He's running really well," Morbitzer said.

"He's gotten stronger in the weight room and has worked hard on getting out of the blocks."

Ward won the 1,600 in 4:34.86 and the 3,200 in 10:13.77.

The Hawks finished second in the 400-meter relay, third in the 1,600 relay and second in the 3,200 relay.

The Hawks' Jamie Watson won the triple jump with a leap of 44-7 and finished second in the high jump.

Bishop England won the 1,600-meter relay in 3:32.16 while the Bishops' Aiden Richter captured first in the 800-meter run, with a clocking of 2:92.90.

The Bishops collected 16 points in the discus as Joseph Storey and Jacob Wilkins finished 1-2. Luke Vettel cleared 12 feet to win the pole vault.

In the girls' meet, Bishop England won the Lower State with 118 points. Waccamaw was second with 88 and May River third with 59.5. Hanahan was sixth with 49 points.

The Bishops won the 1,600 relay with a time of 4:13.04, which was more than four seconds better than second-place finisher Bluffton.

Carla Malark cleared 8-6 to win the pole vault while freshman Emma Albano continued to have an impressive spring. She won the discus with a heave of 102-9 and placed third in the shot put.

Tony Colizzi, who coaches both Bishop England teams, expects Saturday's state meet to be extremely close.

"The state meet is going to be a battle for both the boys and the girls," he said. "The boys will be in a battle with Hanahan, which is very strong. The girls will be in a battle with several teams and it may come down to the 4x4 to determine who wins the state meet. I am really looking forward to the girls 4x800, 800m and 4x4 as those should be exciting races."

### For BE siblings, lacrosse is a family affair!

She's arguably the best female high school lacrosse player in the Palmetto State, and is a member of the National Honor Society to boot.

But Bishop England student-athlete Emma Pizzo's best attribute just might be her modesty.

Just ask her coach, Jeff Weiner.

"She's very modest," Weiner said.
"I'm surprised that she even agreed to do this interview. She doesn't like to be in the limelight or stuff like that. Last year, when she was named the state player of the year, I had to convince her to sit on the dais."

"She's very bright, very studious," Weiner continued. "She worries about academics more than anything else."

Pizzo, who has a 4.7 GPA, is one half of South Carolina's first family of lacrosse. Her brother Andrew, who graduates in a few days from Bishop England, is equally talented and humble. He should repeat as an all-state selection and will continue his athletic and academic careers at the University of Tampa.

It's not unusual to see brother rooting on sister and vice versa when the BE LAX machine plays the same opponent on the same field on the same day.

"He'll come over from his game to watch my game," Emma said. "He will ask, 'How many did you score?' If he did better, he will rub it in a little."

Both have plenty to celebrate as the proud owners of state championship rings. Emma has two of them, including the one she and her Bishop teammates just won on April 29.

The Bishop girls went 14-2 on the season and outscored four playoff foes 81-10. They beat Chapin 15-6 in the state final as Emma scored three goals. She finished the season with 113 points, which led the state. She scored 80 goals and handed out 33 assists.

Andrew, equally impressive, helped the Bishops post a 14-3 record as the Bishop boys won their first state title on the same day as his sister's recent championship game.

"That was something she had that I wish I had," Andrew said of the elusive state title.

The Pizzos grew up in Long Island,

which was more of a lacrosse hotbed than the Lowcountry. The family moved south and that's when the siblings became serious about South Carolina's fastest growing prep sport.

Andrew was one of the team's leaders, a role he gladly accepted. He knows first-hand that underclassmen can be in awe of the older players.

"I like being a role model," Andrew said. "We can learn from each other. A freshman can improve his skills by working hard and by watching how the experienced players handle situations. It really helped me when I was a freshman and I hope it has helped the younger kids this year."

Andrew will matriculate to Tampa because he likes the school, the good weather and the LAX program.

"I wasn't sure how far lacrosse would take me when I first started playing," he said.

His journey started in Long Island and continued in Charleston - with southern Florida slated as his next destination. And while the trip has gone south, he's also been north, to the top of the high school lacrosse mountain.

# High school playoffs recap

The Bishop England baseball team enters Wednesday's Class AAA Lower State Championship against Aynor with an 11-game winning streak, some rested pitching arms and confidence.

The Bishops host Aynor at Father Kelly Field and the visiting Blue Jackets have a tough chore. They must beat the Bishops two times Wednesday night to remain alive. The Bishops have to win only one game to advance to the Class AAA State Championship Series, which commences Saturday.

Bishop England coach Mike Darnell plans to stay the course as his team prepped for the showdown and aims for its first state title since 2011.

What does he tell his team?

"Probably nothing different than we have

talked about before every game," Darnell said. "Pitching and defense...try to put pressure on the other defense. We (coaches) really try to get out of the way once playoffs

The Bishops haven't lost since they dropped a 3-2 decision against Class AAAAA foe Fort Dorchester in mid-April in the Hanahan Invitational Tournament. The Bishop pitchers have been very effective in the postseason, allowing only nine runs (eight earned) in five games.

Darnell is pleased – but not surprised – by his hurlers.

"We knew we had a bunch of arms coming back and thought a few of them have a chance to be special," he said.

Aynor defeated Lake City 4-2 in eight innings Monday night in an elimination game to remain alive and set up the showdown against Bishop England. Aynor enters Wednesday's game with a 19-10 record.

The Bishops, perched in the winner's bracket, didn't have to play a game Monday and have their pitching staff rested and ready.

"We plan on taking the same approach as if it were one game...throwing the guy who is up next in the rotation with the same guys coming out of the bullpen," Darnell said. "Not having to play the extra game (Monday) gives us everyone available for Wednesday."

The state championship series will begin Saturday at the Upper State winner's field. Game 2 will be played at the Lower State winner's field on Tuesday. Game 3, if necessary, will be played at a neutral site on May 20.

#### **TENNIS**

The Hanahan and Bishop England boys'

tennis teams will play Wednesday in the Class AAA Lower State championship.

Bishop England advanced with a 6-0 victory over Brookland-Cayce Monday night. The Bishops, who received a first-round bye, beat Bluffton 6-0 in the second round.

# Biggest ship ever to visit East Coast coming to Wando Welch Terminal

Track COSCO Development's voyage on scspa.com

#### **PROVIDED**

Wide, deep channels and big-ship infrastructure will earn the South Carolina Ports Authority the desired position as last port of call when the biggest ship ever to visit the U.S. East Coast, the COSCO Development, arrives May 13 at Mount Pleasant's Wando Welch Terminal across from Daniel Island.

"SCPA has worked aggressively for years to ensure we can efficiently work 13,000 twenty-foot equivalent unit (TEU) vessels and be the last Southeast port of call with no navigational issues," said Jim Newsome, SCPA president and CEO. "Our naturally wide and deepwater harbor, soon to be the deepest on the entire East Coast at 52 feet, can handle vessels the COSCO Development's size loaded heavy with cargo. Coupled with our landside capacity and infrastructure, including new super post-Panamax cranes, we offer our export customers the opportunity to load their goods in Charleston before the vessel departs for its return to Asia. We also offer excellent transit times for import cargo bound for consumer markets across the Southeast. It's ironic to say, but this is a case in which we've worked very hard to be last."

The ship, which measures 1,200 feet long and 158 feet wide, can transport up to 13,092 TEUs. It is deployed on the weekly OCEAN Alliance South Atlantic Express (SAX) service connecting Charleston with Hong Kong, Yantian, Ningbo and Shanghai via the Panama Canal. The SAX service is comprised of 11 vessels ranging in size from 11,000 to 13,000 TEUs.

Today, 18 of SCPA's 24 weekly container vessel services are comprised of ships too large to transit the Panama Canal prior to its expansion.

"The arrival of the COSCO Development at East Coast ports marks a new



era," Newsome said. "Seeing a 13,000 TEU vessel in our harbor is a tangible reflection that our vision and capital investments to be big-ship ready are absolutely critical."

The COSCO Development's visit is the first of many milestones ahead for SCPA. This fall, dredges in the Charleston Harbor will mark the beginning of the construction phase of the Harbor Deepening Project. Within the next year, a \$44 million project to modernize and strengthen the wharf at SCPA's Wando Welch Terminal will be completed and two new ZPMC super post-Panamax cranes will be delivered from China, complementing the two cranes of this size already in operation.

# DI Moms' Run helps new mothers struggling with mental health

Annual event set for May 13 at MUSC Health Stadium

It is estimated that one in seven new moms will experience maternal mental illness. According to local nonprofit Postpartum Support Charleston (PSC), this means that more women will suffer from illnesses like postpartum depression (PPD), anxiety and obsessive compulsive disorder (OCD) in one year than the combined number of new cases of leukemia, multiple sclerosis, Parkinson's disease, Alzheimers disease, lupus, tuberculosis and epilepsy in the U.S.

On Saturday, May 13, Mother's Day weekend, PSC will host the 14th annual "Moms' Run + Family Fun Day" at MUSC Health Stadium on Daniel Island.

According to their website, PSC is a volunteer-run organization dedicated to eradicating the stigma surrounding maternal mental illness, which includes psychosis during and after pregnancy, to ensure that all women who suffer receive support. PSC offers free peerto-peer support groups, educational programs, as well as grants to women who are unable to afford treatment.

"We want new mothers to know they don't have to suffer and they are not alone," says

Holly Fisher, a board member of the organization and a postpartum depression survivor herself.

Fisher says events like the Moms' Run not only raise funds, but can help raise awareness and promote education.

"PPD can happen anytime during the first year after childbirth," she explains. "And many women do not realize it can also begin after struggles with breastfeeding or during hormonal shifts that occur with weaning. It's important for families and communities to understand the illness as well."

"Many moms have a sense of shame or guilt because they are unhappy during what they think is supposed to be a blissful time," Fisher continues. "PSC encourages women to reach out and seek help as soon as possible if they feel something's not right."

"In my case, I had this beautiful baby and I'm thinking 'What have I done?' It was as though I was in a black hole."

Families don't always know where to go for help, adds Fisher.

"I think PSC provides a tremendous service in this way," she says. "The volunteers at our organization make private phone calls. We have a private Facebook site. We give moth-

ers a safe place...It took more than a year for me to feel I'd come out of the fog, even after I received treatment."

For her, Fisher says, that treatment included medication, therapy and peer-led support groups. "It's a treatable condition, but it also takes time."

Today, Fisher is a happy, busy working mother to nine year old Kate. She says one of her passions is advocating for postpartum health and promoting events like the Moms'

The Moms' Run - PSC's largest fundraiser - is a 5K run/walk open to all ages, followed by free activities for families. Festivities begin at 7 a.m. while the race itself begins at 8 a.m. The course runs through Daniel Island and will end back at MUSC Health Stadium. The event's "Family Fun Day" includes food and music, a jump castle, face painting, crafts, games and a post-race awards ceremony. The cost of all activities is included in race

"Our race not only provides important funds for our work in the Charleston area, but also is a way for all of us to join together and raise up mothers in our community," said PSC board president Elaine DeaKyne.

Registration for the Moms' Run is currently open online at www.ppdsupport.org/events/ momsrun. Participants may also register beginning at 7 a.m. on the day of the race.

Fees are as follows: \$30 per adult; \$35 per stroller (includes one adult and one child in the stroller: \$5 for each additional child in stroller); \$20 for children 10 and under. A \$25 "support the cause" option is available for non-runners who would like a t-shirt and race

# Local Facebook group hits nearly 3000 members

"Have you checked DI Moms?" is a question heard often on Daniel Island, when a parent finds herself in need of up-to-date information.

The "Daniel Island Moms" Facebook page has been the go-to source of current information for many local parents for more than six years. The popular forum was started by Jessica Taylor in 2011 when she moved to the island from New Jersey with her three small children.

"A friend and I were looking for a way to connect with other moms and get to know people, a way to connect this unique island," Taylor says.

Starting with just three members, the page's readership has grown exponentially.

"I remember when I would go up to moms at the pool and ask if they were on Facebook and (if they) would like to join this forum," says Taylor. "Now we have almost 2800 members. Requests come in multiple times a day to join the page."

"When my young daughter and I moved here from New England a year ago, we knew almost no one in the

Charleston area," says Daniel Island resident and mother Kristina Wilmot. "What Jessica created was a wonderful welcome wagon and continues to be an invaluable resource."

Taylor, a stylist at Envy Salon on the island, says she tries to confirm that all of the members are linked to Daniel Island somehow, whether it is through residence, school or work.

"I think it's become an effective forum for Daniel Island moms to ask questions, share opinions, stress concerns... a way to find out information," she explains. "It takes a village so this is one way we can all keep in contact and work together in important situations."

Recent posts on the page vary widely in content - from information about community events to sharing babysitter recommendations, even sharing warnings about poisonous snake sightings.

"I love being a DI Mom because I know we are all on the same page and watch out for each other and our children," adds Taylor.

# DI 'Junior Girls Day Out' program gets down to business

On Tuesday, May 2, the entrepreneurial spirit was in full force upstairs at Laura Albert's on Daniel Island and in select locations around the town center area. The cacophony of soprano-high voices, interrupted by occasional giggles, confirmed that this was not a random meeting of the Women's Island Network (WIN), a group of Daniel Island women in business. At least, not quite yet.

This special event, part of the Junior Girls Day Out Business Start Up program, was, however, a big step in the entrepreneurial direction. The session featured established business owners in the community willing to impart important business skills to nearly two dozen elementary and middle school girls. An audience of legal minors, to be sure. But after a full afternoon of thinking like a boss, they'll soon be as savvy about the business of business - and ready to take their seat at a future WIN meeting.

Junior Girls Business Start Ups is part of Junior Girls Mathematics, Economy and Money, a broader initiative with a focus on teaching young girls financial literacy and solid math skills, a must-have to run any business successfully. This program, in turn,

was developed by the Junior Girls Day Out Community Project (JGDOCP), an organization dedicated to encouraging girls, ages 4 through 14, to achieve great goals in life by developing social, cultural, educational and

financial skills and strengths.

"We try to infuse fun into the curriculum," points out Kathy Jackson, JGDOCP founder. "These young girls go through so much. You have to give them something that's going to

grab their attention...something that's got that 'wow' factor."

Jackson started the JGDOCP in 2007 in response to her own frustration seeing women featured in news reports, both locally and nationally, end up in prison as a result of poverty, powerlessness, lack of education and an all-important vision for their future. Jackson wanted to help turn the tide. But she knew that any effective education had to begin early. Armed with a defined goal and business plan of her own, Jackson turned her vision into a reality with the JGDOCP. Thanks to her efforts, thousands of girls across 15 cities in 12 states recognize their collective "girl power" and are on the road to constructive, fulfilling and joy-filled lives.

The afternoon's keynote speaker was Charleston native Carolyn Hunter, owner of three McDonald's franchises in Berkeley County and a self-made millionaire. Hunter shared her own story, beginning as a reluctant teen-aged job applicant at McDonald's. She pursued the job only at the insistence of her uncle. Hunter started at the bottom flipping burgers in the kitchen (a task, she admits, she learned to enjoy) and working her way up.

Hunter developed a vision of one day owning her own McDonald's franchise. But, she insists, realizing that dream did not come without sacrifices. "I had to save \$50,000 to open a franchise," says Hunter. "I may not have had pretty clothes and shoes, but at the end of five years, I had \$75,000 saved up. Thank goodness for automated savings!"

Soon, Hunter was able to purchase her own piece of the famous Golden Arches.

"It took ten years to turn a profit," she admits. "But I've learned so much along the way...and I've enjoyed every step of my journey."

In 2007, Mrs. Erin Wiseman, then a fourth grade teacher at the Daniel Island School, and her class won an ice cream party for being the top fundraisers in the school's "Loose Change for Leukemia" campaign. The students collected \$299.53 of the school's \$1,944.73 total.

### FIVE YEARS AGO Celebrating Philip Simmons' 100th Birthday

In the May 10, 2012 issue of the Daniel Island News the Daniel Island Historical Society's celebration of the 100th Birthday of Master Blacksmith Philip Simmons was featured. The event, which recognized Simmons as a 'A Poet of Ironwork,' was a proud nod to a remarkable figure in the history of the island, and also served as a fundraiser for the DIHS. It connected the memories of a tremendous Lowcountry artist with the dream of sharing the history of an island he once called home.

It was also reported in this issue that seven endangered sea turtles had made their way back to the ocean. Released by the Sea Turtle Hospital of the South Carolina Aquarium downtown, the turtles had spent several months receiving rehabilitative care for a variety of ailments, including cold-stunning and injuries sustained

from boat propellers. Six of the seven, including the Kemp's ridley sea turtles and one rare, loggerhead-green hybrid sea turtle, were rescued from the waters of Cape Cod and flown to Charleston thanks to assistance provided by Daniel Island businessman Mason Holland and his state-of-the-art Eclipse jet.

Philip Simmons passed away in 2009, just days after his 97th birthday. He would have turned 100 years old on June 9, 2012 and the Daniel Island Historical Society celebrated that milestone in the venue that upholds a marriage of remembrance and aspiration: the Daniel Island Real Estate Sales Center. It is in that space that Simmons' original design for the Daniel Island logo hangs above a history display, conveying to visitors that there is more to this island than meets the present-day eye.






