# Farr Street extension project approved by City Planning Commission

*Plans for new senior apartment complex also in the works*

Work on the long planned extension of Farr Street in Daniel Island's Center Park neighborhood is set to begin next month. A concept plan for the project was approved at the October 19 meeting of the City of Charleston Planning Commission. The new roadway will connect the intersection of Farr Street at Grand Council Street with the intersection of Farr Street at Seven Farms Drive.

In addition to the Farr Street extension, the Planning Commission also approved the subdivision of a 12.6 acre parcel of undeveloped land, owned by the Daniel Island Company along the new stretch, into three separate lots. One of those tracts is likely to be the site of a planned active adult residential community for seniors age 55 and older. That project is being developed by Greystar Real Estate Partners, LLC, the entity funding the completion of Farr Street. Greystar also developed the existing Daniel Island Village apart-

ment complex at the end of Seven Farms Drive. The new senior community will sit to the left of the Daniel Island Village site, behind the Bishop England High School baseball fields and an adjacent pond.

According to Robert Morgan, development director for Greystar, the parcel nearest to the Blakeway Street and Grand Council street intersection will continue to be owned by the Daniel Island Company for future development, while the third parcel will be used to create "a passive linear public park along the marshfront that will become part of the Daniel Island park system along Farr Street."

While the Planning Commission gave the road extension project a green light, several Daniel Island residents who attended the meeting did not necessarily agree it was a good plan. According to Kathleen Fitzpatrick, about 20 residents turned out for the session after learning about it, via a public notice posted in the neighborhood several days prior. Adding to confusion, the notice posted by the city blew off the sign, revealing an old meet-

ing announcement pertaining to a neighborhood in West Ashley.

"No one bothered to knock on the doors of any residents to see if they wanted to have a say," said Fitzpatrick, who lives on Daniel Island but not on Farr Street. "...

This could impact their property values... Decisions are being made and people feel like they don't know what's going on. There is just a lack of communication

# ECCO assists Hurricane Matthew victims

In the past couple of weeks, I have heard many friends and acquaintances say, "We were lucky this time."

I'm sure most our East Cooper neighbors have said the same thing. The day after the storm, I came to the office to see if there was any damage. Thank the Lord, there was none. On Monday, I went to Huger to inspect our center. And again, I saw no damage. While I was there, I toured the community where the "flood of a thousand years" hit so hard, especially the French Quarter Creek area. Once again, there was no loss. As a community, we can be thankful that most were spared any real harm from Hurricane Matthew.

Despite of our visual assessment, there are still those in our community who are suffering in a different way. So who are these victims? Those who work for hourly wages and tips - the working poor. For example, consider the single mother who lives in North

Charleston and makes her living as a waitress in the restaurant industry in Mount Pleasant. As the storm progresses towards the Lowcountry and forecasts show the potential impact on our community, she wants to protect her family and evacuates with her two small children to Columbia on Wednesday night after work when the lanes of I-26 were reversed. She stays in a hotel for four nights and returns to North Charleston safely on Sunday night.

Let's consider this situation from a financial perspective. First, these folks live paycheck to paycheck. Second, account for the missed days from work. If they can't work, there are no hourly wages or tips. It's a no-brainer; employees who are paid hourly don't have any income when they can't work. Third, the costs are what really hurts: four nights in a hotel room; gas for the trip (and extra, extra gas for the long lines of slow moving traffic). On top of these expenses, figure in the cost for meals.

When she returns home and goes back to work, the loss of income has devastating consequences. Her

next month's rent is due. The electric and water bills are owed. She finds herself in a deep hole. It won't be long before the utilities are shut off and/or she faces eviction, which could result in the loss of her children's custody. What does she do?

This mom is only one example of those who are discovering themselves in similar situations. There are thousands of workers, who make up our community (that may not live in East Cooper), finding themselves in these circumstances. What do they do?

ECCO can help! Fortunately, in 2008, a fund was created through a capital campaign that included the financial means to offer emergency assistance after disaster situations. People who live or work in East Cooper experiencing emergency situations like this can find relief at ECCO. Last year after the "flood of a thousand years," ECCO assisted more than twenty of our neighbors in need with home repairs. Should someone incur unexpected expenses due to a catastrophic event like personal hurricane recovery, ECCO can help those who lack the resources needed to get by.

# Looking Down the Barrel

*Gun Sense S.C. kicks off Daniel Island's discussion on guns, youth and keeping violence from the island*

On Daniel Island, the issues of crime - let alone gun violence - seem far away. They seem mere headlines on the television news, someone else's problem. And while Daniel Island is by all accounts a bastion of safety, there is a movement underway to keep it that way. A group of island residents and members of gun safety advocacy group Gun Sense S.C. took on the issue by simply kicking off a conversation on the topic last Thursday, October 20, when they invited islanders to a panel discussion held at Providence Baptist Church on Daniel Island entitled "Keeping our Children Safe."

Gun Sense S.C. members and Daniel Island residents Peter Zelka and Jacqueline Gowe put on the event for the purpose of educating islanders about the reality that what many perceive as someone else's problem is only one tragic moment away from becoming our problem. The panel discussion was non-partisan, and focused on the steps gun owners and non-gun owners alike can take to protect all children from the tragedy of unintentional gun violence.

"We wanted to do an outreach here on

Daniel Island because we live here and this is where we raise our children," said Gowe. "Daniel Island is such a wonderful place to live it's almost idyllic. We wanted to give you the words to use perhaps when you talk to your friends."

The five-member panel featured a bevy of experts in their respective fields: Jackie Shelley of Moms Demand Action, cardiologist Dr. Frederick Jones, psychologist Dr. Kaitlin Bountress, Charleston Police Department Lieutenant and Team Five Commander James Byrne, and event host, Gun Sense S.C. member and Providence Baptist Church pastor Rev. Don Flowers. The evening began with each member summing up the issue from their respective, unique professional perspective.

"I've been interested in safety, but I bring to you this evening a message that we are in a public health crisis," said Dr. Jones. "Despite all the conversations, we seem to lose sight of what we're talking about. If this was heart disease, if this was cancer, if this was AIDS, there would be much more public interest involvement. Of the top 10 leading causes of death, the only (one) of the 10 that has not

decreased in the past decade is deaths related to gun violence. If that's not a public health issue, I don't know one when I see one."

Shelley, the Charleston-area group leader of Moms Demand Action for Gun Sense in America, reminded the room that their proposals are for the gun owner and non-gun owner alike, that theirs is a non-partisan, common sense perspective. "'Moms' is not anti-gun," she said. "We are anti-gun violence and that's an important thing to remember. We want to keep guns out of the hands of dangerous people and we advocate for responsibility and accountability for all adults, but especially those who choose to own a gun."

Shelley introduced the score of island residents in attendance at the discussion last Thursday to her organization's "Be Smart" program, which has a goal of reducing unintentional shootings, homicides, and suicides among children. "We never talk about whether somebody should own a gun. We accept the fact that people are going to choose to own guns. What we do decide to talk about is that you have to assume as an adult that your child is going to enter a home or a vehicle at some point that has a weapon, so you need to make sure you are prepared."

It was Dr. Bountress who spoke next, talking to the crowd about depression in children, warning signs of suicide, and steps everyone can take to prevent gun-related teen suicide. She focused her talk on the plight of parents in trying to communicate with kids battling

depression.


"When they see depression in their kids, some parents become overwhelmed and don't know what to do," said Bountress, a PhD at the Medical University of South Carolina (MUSC). "The biggest thing is to remain calm and try to open up a dialogue with your child about what's going on. If you are able to open up a dialogue, how about their thoughts of self-harm? Be as sympathetic as possible and don't judge them."

As the top cop on Daniel Island, the audience was eager to hear from the friendly, familiar Lt. Byrne. Byrne offered the crowd his perspective on the issue as a member of law enforcement, but first reminded the room that he approached the topic not simply as a cop, but also as a father. That said, his knowledge on the criminality angle of gun violence proved information in high-demand.

"Most people who are gun owners, we will never know," began Byrne. "We'll never see them, we will never come in contact with them, because most people who own guns either do so responsibly or do so in a way that we never encounter through police work. There are some people who despite their best intentions we do end up coming in contact with, and most of the time that's through theft."


"A stolen gun becomes a crime gun and a crime gun is usually not used for anything positive," Byrne continued. "Unfortunately, we've had four guns stolen this year on Daniel Island,

## Extension of Farr Street is set to begin next month

with residents.”

Farr Street resident Patricia Kottka agrees. She fears there are likely to be potentially negative traffic impacts to her now quiet neighborhood once her street becomes a thoroughfare connecting the western side of the island with Seven Farms Drive.

“It’s going to become a major roadway and it’s not designed for that,” Kottka said.

“The Farr Street extension provides a third access point to Seven Farms Drive from Daniel Island’s southern neighborhoods, which should ease traffic,” stated Morgan. “The other roads being Daniel Island Drive and Etiwan Park Street.”

News about Greystar’s planned senior housing complex for the Farr Street extension also sparked concerns for Kottka, who feels there are already too many apartments on the island.

“Nobody knew,” she said. “People were blindsided and there has been no transparency. Why didn’t it get out to the general public?”

The new senior complex hasn’t been

publicized yet, explained Daniel Island Neighborhood Association (DINA) Land Use and Zoning Chair Clyde Rush, because it has yet to begin the various phases of the city’s approval process. Its first stop would be the city’s Technical Review Committee (TRC), he said. According to Rush, Greystar officials discussed the project with him so that DINA would be aware of their plans. He hopes to provide some details on the complex at the November 1 DINA meeting. Once the project gets on the TRC’s agenda, more information will be available, he said.

“We will see everything as it moves forward,” added Rush.

According to Morgan, the senior apartments will be known as “Overture Daniel Island” and will be a high-end, age-restricted residential community. There will likely be between 180 and 200 units, he said, as well as adequate on-site parking. The parcel of land on which the apartment complex would sit is currently owned by the Daniel Island Company, added Morgan, but Greystar expects to purchase the property in 2017.

“Overture Daniel Island is intended to provide a much-needed housing option on Daniel Island for the aging, Baby Boomer generation,” stated Morgan, in an email to The Daniel Island News. “...As an age-restricted active adult community, traffic will be significantly less than a conventional residential community, and the school impact will be nonexistent.”

Kottka says she knows there isn’t much, if anything, she and other residents can do to stop the road extension or apartment complex from being built, but she hopes the third parcel, adjacent to the Farr Street and Grand Council intersection, is not used for another multi-family development.

“We don’t want the second half developed if we can prevent that,” added Kottka. “...No more apartments. People are done.”

After the October 19 Planning Commission meeting, Kottka, Fitzpatrick and other residents spoke with Greystar representatives, who told them they would be happy to meet with them to discuss their concerns.

“We’re getting mobilized and we want to get the word out,” said Kottka, who is interested in offering some feedback to the developer on plans for the complex.

Fitzpatrick agreed it was a good first step.

“At least there is a dialogue opened,” she added. “...They were willing to come to the table. That was as much a win as we could have expected.”

Rush, who continually updates the DINA website to include announcements on all Daniel Island development projects making their way through the city review process, urged residents to stay informed while not rushing to judgement.

“The road was always part of the island’s master plan,” he said. “From what I see this is a normal part of the development of Daniel Island. As for the apartments, from the Greystar perspective, let’s wait and see what they propose. Nothing has been formally proposed. We can react at that time. I think it’s important that we don’t overreact.”

Once construction begins on Farr Street in mid-November, planners estimate it will take about 18 months to complete. 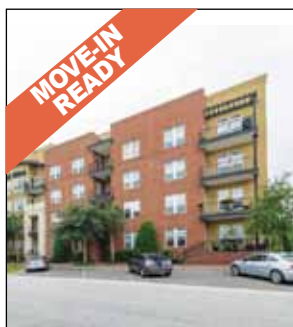

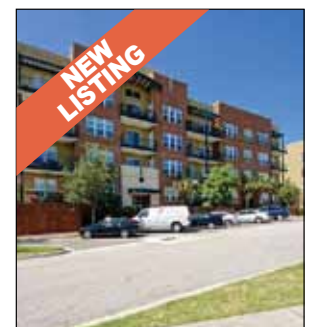

### JUVENILES CHARGED

Two juveniles, age 13 and 14, have been charged in connection with a series of thefts on Daniel Island. One of the suspects is a Daniel Island resident and the other resides elsewhere in Berkeley County, according to police. The offenses, which occurred between March and May of this year, involved some 20 cases of property crimes, including thefts of a firearm, golf cart, and motor vehicle, as well as burglary and drug charges.

### STOLEN CARS RECOVERED

Two vehicles stolen from Daniel Island earlier this year have been recovered in North Charles-

ton. The cars were taken from residences in the Etiwan Park and Codner's Ferry Park neighborhoods. Possible suspects have been identified and the cases remain under investigation.

### MULTIPLE THEFTS FROM MOTOR VEHICLES ON DI

Police report that close to a dozen vehicles were targeted by thieves between October 2 and 3 on Daniel Island. Multiple items were taken, including a loaded gun that was removed from a vehicle parked in a driveway in the Etiwan Park neighborhood. According to police, all of the vehicles hit were unlocked at the time and showed no signs of forced entry. The cases are under investigation, but police believe the culprits are adults who live off the island.

Police are also investigating two additional thefts from motor vehicles that are not related to

the above mentioned cases. These incidents occurred in Daniel Island Park sometime between October 16 and 17. The suspects reportedly entered an unsecured truck parked at a residence and removed a laptop. The same night, another unlocked vehicle was targeted and the suspects took a firearm. Both cases are under investigation.

### VEHICLE REPORTED STOLEN FROM PENINSULA SUBDIVISION

A woman notified police on October 11 that her car had been stolen. She left the vehicle on River Reach Road after it became disabled, according to police. The vehicle was reportedly locked at the time. When she returned, the car was gone.

### LOCK BOX FOUND

On October 17, police received a call that someone had dropped off a lock box at an apartment complex on River Landing Drive. The box had been found in a nearby parking lot. Police

responded and identified the owner, who stated she had inadvertently dropped the box while in a parking lot on Pier View Street. The box contained a number of important documents and possessions and the victim was "very grateful" that it had been located, stated police.

### THEFTS FROM BUILDING

City of Charleston Police were called to a Daniel Island hotel on October 1 in reference to two thefts of money from rooms at the facility. The guests were out of the rooms at the time the thefts occurred. Officers have a warrant pending in the case.

### THEFT OF TRAILER

An automobile carrier-style trailer was taken from a residence on River Walk Court, located in a neighborhood off Clements Ferry Road, on October 20. The theft took place during the day.

two of them just this month. All of them that I'm aware of were stolen from unlocked vehicles. It's a problem at the Charleston level and it's also a problem at the national level."

It was Rev. Don Flowers who wrapped up the panel's commentary portion of the evening by addressing the topic from an evangelical perspective. "I've looked and nowhere in the Bible does it talk about how we should deal

with guns. It talks about a few simple things like 'Thou Shalt not Kill.' And we can leave it there, and not have to think about it again because we're here on Daniel Island and this is a safe place." But Rev. Flowers then turned to the story of Saul, recounting how he stood by silently during the stoning of the first martyr, Stephen.

"The story is that he didn't throw a single stone, he just stood there and didn't say a word and the people who stoned Stephen laid their coats at his feet...I wonder for us how many times we've decided we're going to be 'Saul

people,'" continued the affable Flowers. "We don't talk about this because we don't like to deal with sad stuff. We don't want to be the downer at a cocktail party, we don't want to be the parent that brings up some issues that might cause a problem with another parent."

In concluding the evening's discussion, Gowe reminded the room that the event was not meant to be the end of the conversation about gun ownership, gun safety, and gun violence on Daniel Island, but rather the beginning. "Speaking about guns can be awkward and people are often afraid to say their feelings

(about guns), but when it comes to our children, I think we as parents and adults in our community have the responsibility to have this conversation," said Gowe.

# The Idea Island

To the many families, small businesses, organizations and corporations that have settled on greater Daniel Island, the place itself has undergone a profound, important transition. In the past, the island was a hot location attracting spillover growth from greater Charleston and Mount Pleasant. Today, for all involved it has become “home” in every sense of the word.

Daniel Island has become a home in another sense as well: it’s become a home to ideas. viewing parties, a pair of island residents played a major role in its production. Mary Beth Natarajan, Daniel Island resident and president of the Jazz Artists of Charleston, headed up the event's marketing and branding efforts, and fellow Daniel Islander Kate Boehm Jerome was a selected speaker at the event (look for a feature article in next week's issue of The Daniel Island News on Jerome's Tedx participation and her experience as a student at the Stanford University Distinguished Career Institute.)

For Paul Sorensen, owner and operator of the unique, collective workspace venue Holy City Collective, participating in TEDxCharleston was a no-brainer. "The TEDxCharleston Executive Team actually meets here," said Sorensen. "What we want to do is help forge new ground in the City of Charleston. For us, we see Charleston as being not just a place to experience the TEDxCharleston talks, but also a place where TEDx fans can rub elbows with like-minded people."

Last Wednesday, viewing party attendees got their chance to do just that. In the spirit of all that is the TED Talks and TEDx

speakers' series, the conversation engendered at the event was fruitful. "I think Charleston is at its own tipping point with population growth and transportation infrastructure coming to a head," said one live-viewing attendee, Mt. Pleasant resident and Blackbaud employee Caleb Copper.

Another attendee, Clements Ferry Road resident Gigi Manning, embraced the mantra of TED by taking the discussion a step deeper, introducing the concept of gentrification into the conversation. "All developers are thinking about is dollars and sense, there's no thought about neighborhoods, communities," said Manning, a U.S. Air Force veteran, BP employee, and a 31-year resident of Charleston. "You can't just displace people on a purely monetary basis."

The conversation that took place around the live viewing of TEDxCharleston: Tipping Point, held in one of several conference rooms inside the inspirationally organized workspace at Holy City Collective, serves as a perfect example not only of the kinds of conversations happening every day at Sorensen's business he says, but on

Daniel Island and in greater Charleston as a whole.

"I think that from within Charleston there's a culture of excitement, creativity, and innovation, but even beyond Charleston," said Sorensen. "Charleston has become a destination for people and companies to move to. It's become a destination, not just for tourism but for innovation."

If he's right, Charleston indeed has reached its own tipping point.

In Guidepost magazine a number of years back Luciano Pavarotti relates a story from when he was a boy and his father introduced him to the wonders of song. He recounts, "He urged me to work very hard to develop my voice. Arrigo Pola, a professional tenor in my hometown of Modena, Italy, took me as a pupil. I also enrolled in a teachers college. On graduating, I asked my father, 'Shall I be a teacher or a singer?' "Luciano,' my father replied, 'if you try to sit on two chairs, you will fall between them. For life, you must choose one chair.' "I chose one. It took seven years of study and frustration before I made my first professional appearance. It took another seven to reach the Metropolitan Opera. And now I think whether it's laying bricks, writing a book – whatever we choose – we should give ourselves to it. Commitment, that's the key. Choose one chair."

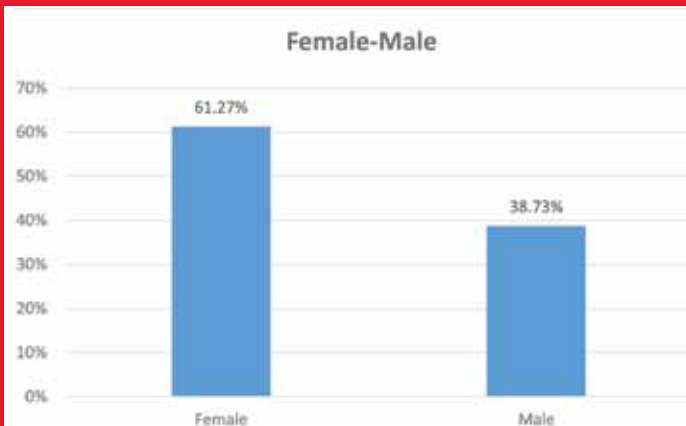

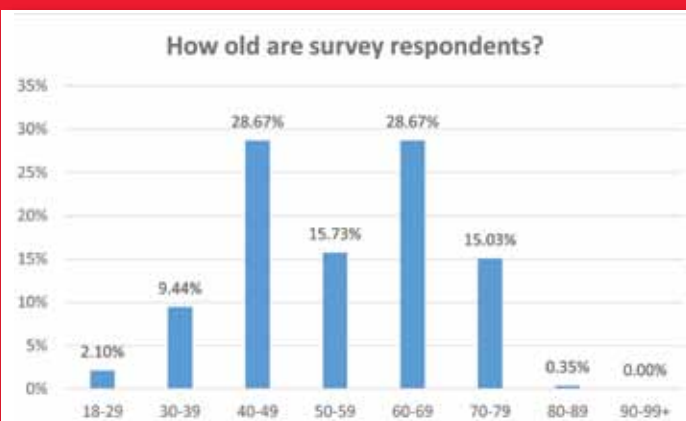


## WHO TOOK OUR SURVEY?

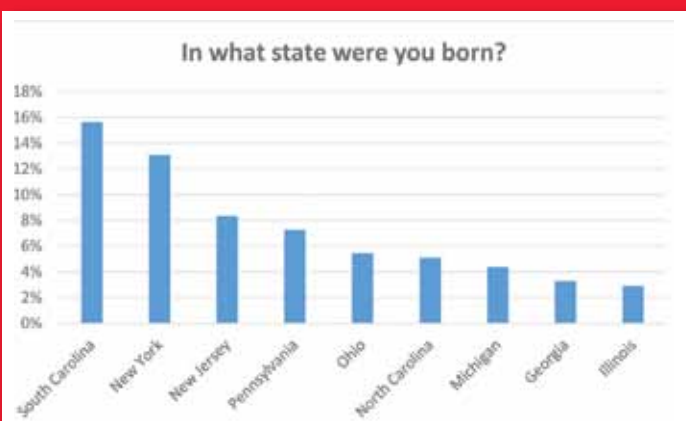
Again, this survey is not scientific, therefore overall numbers do not necessarily reflect the sentiment of all Daniel Island voters. Nonetheless, certain trends and comments are noteworthy. We begin by first explaining who took the survey, based on gender, age, political orientation and political preference.



Of the 291 residents who responded to the survey, 61% were female, 39% male.



Survey Respondents: less than 12% are under 40 years old, more than 44% are age 60 or older.



Among those who filled out the survey, more than 15% were born in South Carolina, trailed closely by New York, New Jersey, Pennsylvania and Ohio. All told, survey respondents listed 34 states plus a host of foreign countries.

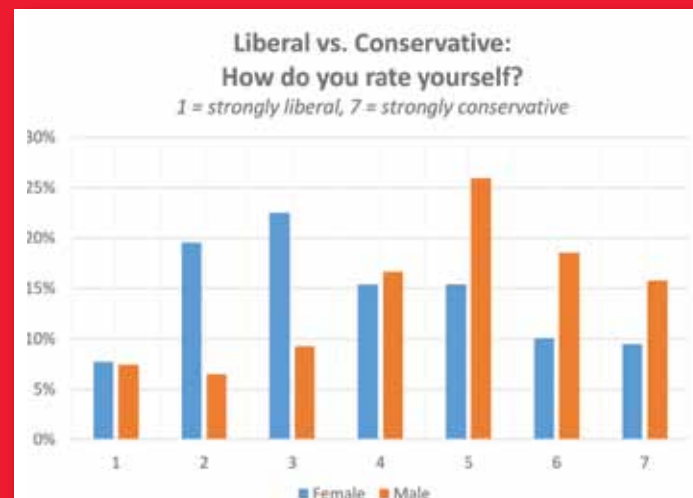

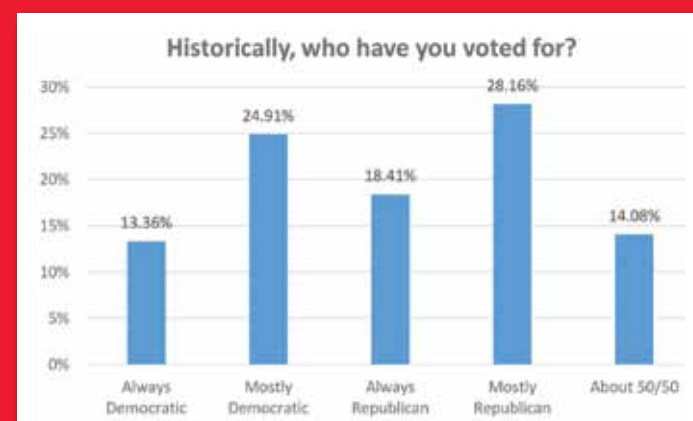
### Selected comments

Filtering the data based on gender and political orientation, here's what we learned about the 291 survey respondents:

- Women: Nearly 8% of women labeled themselves as "strongly liberal" with 9% saying they're "strongly conservative." Overall, 50% of women said they're on the liberal side of the aisle, with 15% in the middle, 35% on the conservative side.
- Men: 7% of men labeled themselves as "strongly liberal" with 16% saying they're "strongly conservative." Overall, 23% of men said they're on the liberal side, 17% in the middle and 60% on the conservative side.



The chart above illustrates that survey respondents, in general, are evenly balanced between the major parties, with slightly more respondents voting Republican in years past.

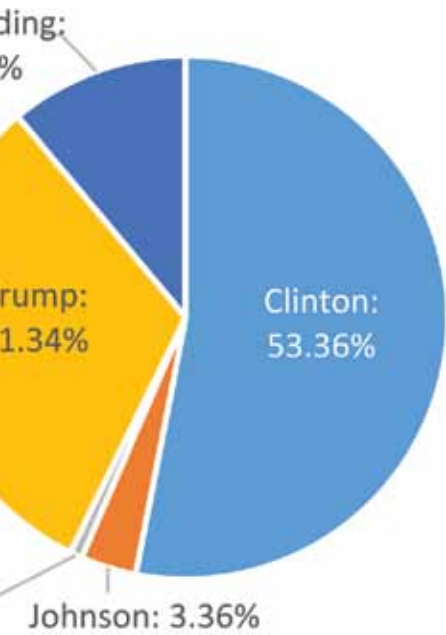

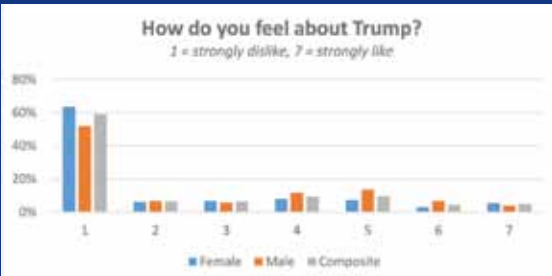
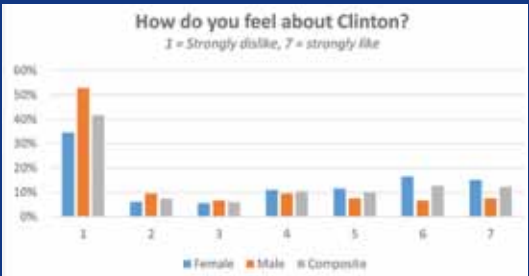

# Football outcomes flip for BE and HHS

It was a reversal of football fortunes for Daniel Island area high school teams Hanahan and Bishop England on Friday night.

Hanahan, which has struggled most of the season, arguably had its best game of 2016, with a 47-0 victory over Lake Marion in Region 7-AAA play.

Bishop England, meanwhile, was handed its first loss of the season, dropping a 26-22 decision to Manning in another Region 7-AAA contest.

Hanahan's victory was pretty much in the bag at halftime as the Hawks led 27-0 against a team that was shut out for the third straight game. Running back Jerry Bailey had a huge effort while quarterback Victor Colbert and wide receiver Davontae Grant contributed to the offensive explosion. The Hawks turned the ball over four times or the score would have been even more lopsided.

"We moved the ball consistently," coach Charlie Patterson said after his team improved to 3-6, including 1-2 in region play. We had a good running game."

Patterson was also pleased by his team's defensive effort. It was the Hawks' first shutout of the season.

"We didn't allow the big play all night," Patterson said. "In the past, we would play well on a drive, but give up the big play. In high school football, if you make a team drive down the field, they are more likely to make mistakes and turn the ball over."

Bishop England fell to 7-1, including 1-1 in conference play. The Bishops entered the game ranked No. 5 in the state, but now find themselves in third place in the region. Both

Timberland and Manning are undefeated in league play.

Manning quarterback Jalen White scored on a 21-yard run with 4:43 left in the game to settle the issue. The Monarchs outscored BE 13-8 in the final quarter to push their record to 6-2, 2-0.

But it was White's arm and wide receiver David Fulton's hands that did most of the damage.

White completed 10 of 14 passes for 233 yards and two touchdowns. Fulton, one of the top junior receivers in the state, had all 10 receptions.

Bishop England quarterback Leo Albano rushed for 138 yards and a touchdown. He was 7 of 11 passing for 113 yards and two scores.

Albano threw a 21-yard touchdown pass to Christian Greavu for the first score of the game. He added a 16-yard scoring strike to Andrew Pizzo to give the Bishops a 14-13 lead late in the first half.

Originally, this was the final week of the regular season for Class AAA, AA and A teams that compete in the High School League.

But Hurricane Matthew forced postponement of all games in the state a few weeks ago. That extended the season an extra week.

Bishop England hosts Timberland this weekend. The Wolves are 4-3, including 1-0 in league play.

Hanahan has an open date and faces Timberland next weekend.

"We've already had one open date because we played in 'Week Zero,'" Patterson said. "At this stage of the season, you'd rather be playing. But it's good to be able to fine-tune a few things and not have to worry about coming up with a game plan. We just have to get better at the things we do best."

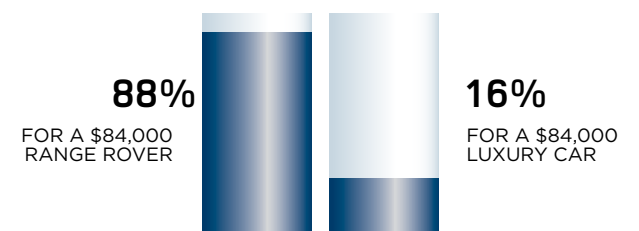

# Now is the perfect time to give fly fishing a try



## fishing trends

GREG PERALTA

Recently, I have received several notes from Daniel Island residents that are interested in fly fishing. Now is the perfect time to give it a try. As the water cools (and clears up), large schools of

Redfish will take up station on shallow (oyster laden) flats. On calm days, it is not unusual to see multiple schools of fish milling about in shallows. Targeting these schools of Redfish is a great way to hone your fly fishing skills. Right now, the fish are very focused on eating shrimp. So any fly that looks like a shrimp will work. I prefer a tan over white Clouser Minnow (with bead chain eyes).

Saturday was not a calm day. A strong

cold front pushed through the Lowcountry on Friday afternoon. In its wake were blue bird skies, a rapidly rising barometer and strong northeasterly winds (post cold front conditions that make fish hard to catch). Regardless, I loaded my fly rod (a TFO 7 weight) and launched the skiff into the incoming tide. The Wando River was very rough but I managed to find a nearby wind-sheltered flat. Good fortune was with me as I spotted a school of Redfish almost immediately. They were about 100 feet away and chasing shrimp. So I quickly un-racked my fly rod and made a long cast. The wind (more like a gale) blew my presentation way off the mark. A fast follow up cast put the fly (a tan over white Clouser Minnow) into the right zone. A couple of fish broke from the pack and attacked the fly. Line began peeling off my fly reel at a rapid pace and I had to chase the fish with the trolling motor to regain my line. When this is happening do not try to take a video with your phone (as I dropped mine into the water). Like I said, good fortune was with me as

I landed released the fish and found my phone (it actually still works). Samsung 7 phones may catch on fire but they really are waterproof!

If you have an interest in learning more about fly fishing, the Daniel Island Inshore Fishing Club will be meeting on Sunday at 3:00 p.m. at the pond across from the Beresford Creek boat landing and Bellinger Island. # The journey that will last a lifetime

On Friday night, Leo Albano III will watch his son, Leo Albano IV, quarterback the Bishop England football team in its game against Timberland.

Early the next morning, the Albanos will get in the car, drive to Myrtle Beach, hop on a jet and fly to Chicago on a trip that will last less than 20 hours. The journey, however, will provide memories that will last a lifetime.

The elder Albano is a Chicago native and a long-suffering Cubs fan who wants to be there when the Cubs attempt to exorcise curses, jinxes and even some bad baseball when they make their first World Series appearance in 71 years. The Cubs last played in the Fall Classic in 1945. If you think that's depressing, they haven't won a World Series since 1908.

The Cubs were scheduled to play Games 1 and 2 in Cleveland beginning Tuesday. The Series shifts to the Windy City Friday night, and the Albanos will be there for Game 4 on Saturday. They will fly back early the next morning.

The Albanos couldn't get tickets to gain admission to Wrigley Field so they will hang out at a restaurant nearby and watch it on a

big screen with a few thousand friends, family and fans.

"The tickets are almost impossible to get," Leo Albano III said. "From what I hear, standing-room-only tickets are going for \$2,000 apiece because everyone's working their connections. You have 108 years of connections working against you. I just want to be in the presence of Wrigley Field. It's something I want Leo to experience."

Albano knows all about the Cubs' history, which is the epitome of bad mojo. He wasn't alive in 1945 when a bar owner placed "the Curse of the Billy Goat" on the team after he and his goat were ejected from Wrigley Field.

He's still traumatized by what happened in 1969. That's when the Cubs were in first place for 155 days, until mid-September, when they lost 17 out of 25 games. Some superstitious fans attribute the Cubs' collapse to an incident during a game against the New York Mets at Shea Stadium in New York. A black cat walked behind the Cubs' on-deck circle where Cubs legend Ron Santo was standing. The Cubs were never same.

And, of course, there was the 2003 NL Championship Series game against the Florida Marlins when the Steve Bartman

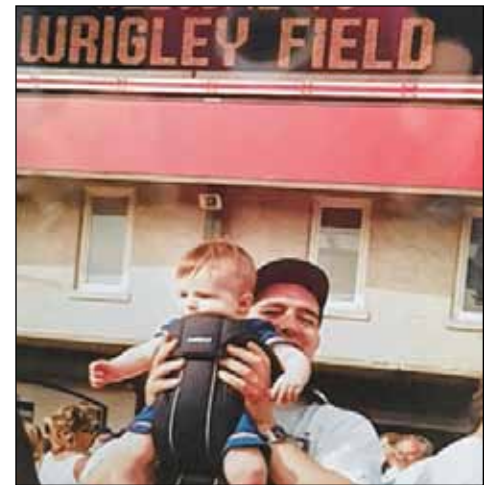
incident occurred.

The Cubs led the NL Championship 3 games to 2 that fall and were leading Game 6 by a 3-0 margin. They were five outs away from an appearance in the World Series when Bartman tried to catch a foul ball that disrupted a potential catch by the Cubs' outfielder Moises Alou. The Marlins got new life and ended up scoring eight runs in the inning. The Marlins won the game, and took Game 7 the following night.

The elder Albano still feels his parents' pain. They haven't given up hope. It's still not unusual for his 80-year-old mother Louise to show up at Wrigley for a game. She lived on the South Side and grew up a White Sox fan. She made the religious conversion to the Cubs in 1960 when she married Albano's father and the family settled on West Addison, which happens to be the same street where Wrigley Field is located.

Leo Albano IV, who also is a star pitcher for Bishop England, feels his family's pain. He was born in late 1999 and went to his first Cubs' game the following summer.

When he was in the first grade, he wrote a paper about what he wished for in life. He wanted to make his grandmother happy by pitching the Cubs to the World Series cham-

pionship. Then, he would make his parents happy by joining the priesthood.

All the suffering could end in the next two weeks.

"If the Cubs win, my celebration won't be for me," Leo Albano III said. "My celebration will be for my mother and all the people who have waited even longer for this to happen."

And if the Cubs lose?

"I know," Albano said. "I know. It's wait 'til next year."

During the month of September, 28 homes sold on Daniel Island. Total sales equaled \$18,956,706. There were six homes that sold for more than one million dollars, while eight homes sold for less than \$300,000.

As of October 17, there were 175 homes for sale. One hundred and four were active and 71 were under contract.

Hayden Jennings analyzed last month's data on single family homes on Daniel Island and compared it to one year ago.

"The supply of single family homes listed for sale this September remained near the same as the September 2015 level at 67 homes, however the number of new listings in September increased dramatically over the same time period last year with a 57 percent increase," reports Jennings. "The number of closed sales

were 15 percent higher than the same time last year. The average listing price is virtually the same while the percentage of list price versus sales price increased, coming in at almost full price at 99.7 percent. Days on the market and inventory are also about the same compared to September 2015."

# Helping & Healing Cancer Warriors

With one in eight women diagnosed with breast cancer alone, most every American family has been touched by some form of cancer. Often a patient's loved ones, friends and neighbors want to show they care, but are unsure of the most helpful ways they can lend a hand. From housekeeping to humor, our survey lists the top 10 ways you can make a difference in the lives of someone living with cancer. In no particular order, they are:

### 1. FOOD

Many survivors found that meal planning was invaluable. Whether it's the home-cooked comfort food they crave or fresh pressed organic juices, online services like [takethemameal.com](http://takethemameal.com) provide free, simple ways to coordinate meal deliveries. Using a service like this allows patients to list their food preferences and makes sure each volunteer can sign-up when deliveries are needed most.

### 2. JUST BEING THERE

Survivor Leslie Moore, founder of the Charleston-based "Warriors 4 Warriors"

foundation, fondly remembers the "drip dates" her friend's organized. For each of Moore's 16 chemotherapy treatments, a pal would accompany her.

"Chemo infusions can last for hours, so the bond you form runs deep. Oddly enough it was some of the sweetest time I spent with loved ones," Moore remembers. "It made the day positive in an unexpected way."

Mount Pleasant resident Lisa Nesbit just completed chemotherapy. With her cancer in remission and a clean bill of health, Nesbit credits her husband's support. "He was there for every session and always gave me a soft place to land," Nesbit says. "He made it easy for me to rest guilt-free. I realize how lucky I am to have that kind of support."

### 3. HAVING FUN!

Nesbit's friend Wendy Taylor says she makes sure to treat Lisa "as her friend, not (her) sick friend."

"I want Lisa to know I see her for the bright light that she is," Taylor explains. "Lisa is adamant that she will not let cancer define her. So we do things that have nothing to do with cancer...we go for coffee, a movie, a girls' night

out. We wanted her to see her illness for what it was: Temporary."

### 4. YARDWORK

"I was overjoyed every time I came home to a mowed lawn!" Moore says with a laugh. Another survivor remembered waking up to a flower garden that friends had planted overnight, "those blooms made me feel so much brighter-- for months!"

### 5. HOUSEWORK & CHILDCARE

Since cancer treatment often zaps a patient's energy, everyday housework can be a challenge. Coming home to a clean house or the laundry folded can be a huge relief. One of the Lowcountry's most popular housekeeping services, Castle Keepers, offers free house cleaning for women undergoing chemotherapy.

Childcare, whether it's scheduling pick-ups or paying for a babysitter, can also be an obstacle for young mothers with the disease.

"My family would take my son to the park or to playdates," says Daniel Island School teacher Lara Rodgers. "Their help meant the world and allowed me to keep working throughout my treatment."

### 6. AESTHETICS

Women with breast cancer often wrestle with their body image during and after treatment. Amy Jetter, a registered nurse at Mount Pleasant's Shepherd Integrative Dermatology, says their office is dedicated to helping women look and feel their best again. "We offer (costly) laser scar removal to breast cancer survivors at no charge."

"Women have told me they feel guilty or vain for focusing on how their body looks," says Jetter, a survivor herself. "But liking what you see in the mirror can be an important part of healing."

### 7. CARDS & GIFTS

Whether it's a beautiful head scarf or hat, a letter of encouragement or a relevant book, who doesn't love receiving a present in the mail? Here are a few favorites our survey found:

- Gift certificates for healing or relaxation treatments such as facials, massage or pedicures. (Many spas or practitioners will give a discounted rate if they know the recipient is going through cancer treatment.)
- Journals.
- Yoga or gentle fitness classes
- Hats that are stylish and not necessarily

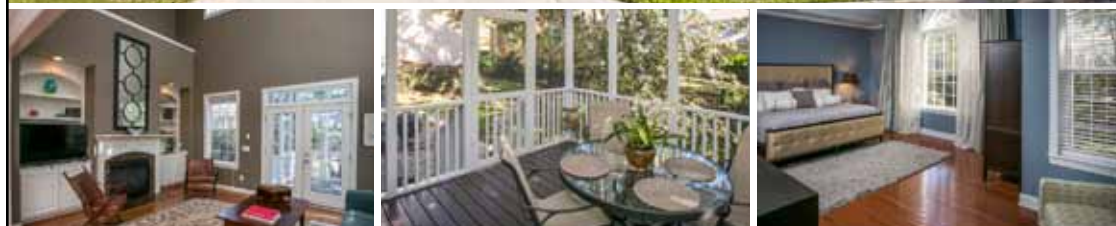

made for chemo patients, such as the “Coquette” hat from Banana Republic.

- “TLC” headscarves from the American Cancer Society.

- Books by bestselling authors Kris Carr or Dr. Jerome Groopman, M.D. that focus on practical ways to heal.

### 8. HUMOR

During the darker days of cancer treatment, a

little levity can go a long way. One survivor said her favorite gift was a set of DVD's of Mel Brooks films. Another loved her “Far Side” calendar of cartoons by Gary Larson. There is medical evidence to support that laughter stimulates endorphins in the brain, creating an anesthetic effect on the body and an improved outlook overall. Whether it's a hilarious book, a goofy mime, or a phone call with a funny story, the gift of humor can actually be healing.

### 9. PRAYER AND MEDITATION

If time or money are an issue for the giver, one can still give one of the most important gifts... prayer or guided meditation. In her tome *The Breast Book* Dr. Susan Love, widely considered one of the country's foremost experts on breast cancer, touts the positive impact that prayer can have on patient recovery rates. Love references several studies that contend that prayer/meditation has been shown to actually decrease psychological distress and increase survival rates in breast cancer patients.

### 10. KEEP IT UP

MUSC Oncologist Dr. Frank Brescia stresses the need for ongoing care. “The after effects of treatment, whether it be ‘chemo brain,’ recovery from surgery, or reactions to hormone therapy medications, can last for years.”

Moore, whose foundation aims to improve the lives of patients from all walks of life, echoes this statement. “Continued support is crucial. After the treatment, after the hair starts growing back... the cards and flowers stop. I would encourage others to extend their support even after the dust settles.”
